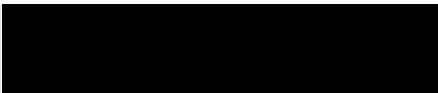

CO-DEFENDANT B

On February 5, 2016 at approximately 1545 hours, I Officer B. Pickens P#14322 operating as marked patrol unit 3M19 and Officer N. Sylvia P#11524 operating as marked patrol unit 3M6 was dispatched to the High Roller security office located at 3545 S. LV Blvd, Las Vegas, NV 89109 in reference to a male and female exposing themselves indecently. Upon arrival, I made contact with Diana Mendez DOB [REDACTED] who was working as an Operation Lead for the High Roller (the observation wheel).

Mendez told me she responded to a co-worker's request at the observation wheel platform about a male and female who were smoking inside the cabin 16 and undressing. The cabins on the high roller are round and have glass walls from floor to ceiling allowing no privacy in the public place; the High Roller is also a visible tourist landmark at the center of the Las Vegas Strip. Mendez said she asked the guests via an overhead intercom specific to their cabin to put out the cigarettes and to put all their clothes back on. Mendez said they stopped momentarily, complying with the request before continuing

to undress as they were before. Mendez said she switched the observation from that cabin to the cabins adjacent to it to see if anyone else noticed the male and female undressing. Mendez said the cabins next to this cabin were occupied with guests. Mendez said she visually observed the guests in cabin 17 didn't seem to notice but the guests in cabin 15 not only noticed but were video recording the acts with what she thought was their cell phones. Mendez said she waited at the platform for the guests to finish the ride. She talked to the guests in cabin 15, 2 males and 1 female, who all said they had footage but didn't want to write a statement. Mendez notified security who took the male and female into custody and notified the police.

I made contact with the male and female in custody in the security office. The male verbally identified himself as Philip Frank Panzica III DOB [REDACTED] and the female identified herself as Chloe Alexis Scordianos DOB [REDACTED] which was confirmed with a records check. The records check also revealed Panzica had an outstanding warrant out of Laughlin Township Justice Court Case #10MCL005836 which was confirmed by Ashley P#9283. I asked them both if they knew why I was here today. They both said they were just having a good time and didn't think anyone would notice.

Security advised me they had video surveillance of Scordianos and Panzica inside cabin 16. Officer Sylvia and I observed the video which I clearly saw Scordianos laying on her back in the center of the cabin. Panzica was on his knees over Scordianos and removed her dress. He also removed his clothes while standing up exposing his penis and bare buttocks, allowing anyone in public to see as well as the operators of the CCTV. Scordianos was also naked exposing her naked body. Panzica then got back down and began to perform cunnilingus with Scordianos. Mendes told me she observed this sex act occur and gave verbal commands over the intercom to stop but they did not. Several security officers and managers also told me sex acts and public indecency on the High Roller are happening more often which they fear will impact the reputation and business operations of the High Roller.

Based on the facts and circumstances above, I arrested Scordianos for both the outstanding warrant and for Commission of Certain Sex Acts in Public – NRS 201.190 for committing cunnilingus in a public place. I impounded a DVD of the video surveillance which recorded the sex act at CCAC Evidence Vault. Scordianos was transported to CCDC where he was booked accordingly.
