eventually identified as that of Teraye Lyles, DOB Doctor Olson also conducted an autopsy on the body of Teraye Lyles and at the conclusion of the autopsy determined that the cause of death was multiple gunshot wounds and the manner of death was homicide.

The scene was searched and processed for evidence. Nine 9mm cartridge cases were found in the scene. Four associated with the body of Dunbar, four associated with the body of Lyles and one that was located in between the others. That shot is believed to have been fired at Dunbar as he ran from the shooter. All nine cartridge cases had the same head stamp, "R-P 9mm Luger". Cartridges with the same head stamp were found in the loaded 9mm Marlin rifle with scope, also found at the scene.

Detectives contacted and obtained statements from several witnesses. Raymond Wurst told Detective Embrey he was standing outside his front door (Apartment smoking a cigarette when he observed a group of black men yelling and screaming. Wurst said there were two groups, one of 3-4 men and the other had 5-6 men. Wurst observed one man take his shirt off and it looked like he was getting ready to fight. Wurst walked back inside his apartment to tell his wife there was going to be a fight outside. As Wurst walked back outside he heard one of the men say "if you got that gun, you better bring fire if you're gonna use the damn thing." Wurst observed a man carrying a rifle that had an extended magazine. Wurst described the man with the rifle as having long dreadlocks or braided hair and was wearing a leather trench coat. The man was approximately 20 to 30 feet from Wurst. The subject with the rifle was approximately 6'0-6'2" tall and weighed approximately 150-160 lbs. Wurst believed the male was in his late 20's to early 30's. Wurst saw the man with the gun go toward the front of the complex and then he heard four to five shots. Wurst saw the man running toward the back of the complex when he heard another five to six shots. Wurst called 9-1-1 and reported the shooting. While on the line he heard two additional shots and observed the same man running back toward the front of the complex. Wurst said it appeared to him that the man with the gun was the main aggressor. Wurst thought he might have seen the suspect in the complex before and might be able to identify him.

Christopher Green is a black male, 29 years of age, 6-02, 165lbs, with his hair in dreadlocks. This matches the description given by Raymond Wurst of the subject he saw with a rifle. Wurst was also correct when he described the rifle as having an extended magazine.

Detective Mogg interviewed Mark Hale who lived in Building Apartment with his girlfriend Phillis Boone, his 69 year old mother Karen Hale, and his friend Gary Allen Smith. Hale's apartment was located on the second floor in the northwest corner of Building Hale said he saw a black male, whom he knows as "Sincere", shooting a rifle at another person in the grass area on the west side of his building. Hale described "Sincere" as a Black male, approximately 30 years old, 6' tall, thin, with shoulder length dreadlocks. "Sincere" was armed with a rifle, and fired at least two shots toward the north as he chased another person northbound on the west side of Building Hale did not see who "Sincere" was shooting at.

Hale said he knows "Sincere" because "Sincere" told Hale he used to live with his niece in apartment and Hale has spoken to "Sincere" on several occasions. Hale said "Sincere" moved to an apartment on the north side of the complex about a month prior due to a water leak in apartment

Detective Mogg interviewed Phillis Boone who said she was in her bedroom late in the evening on 10-20-2013 when she heard several black males arguing in the courtyard outside of her window. It sounded to her that the argument was over a girl. Boone didn't know the people who were arguing with the exception of two, whom she described as a black male named "Sincere" and his girlfriend whom she described as a black female, 35 years old, 5'8 and heavy set. Boone said "Sincere" was wearing a dark colored zip-up hooded sweatshirt. Boone said the argument lasted for six or seven minutes before the group walked off to the west in the direction where the picnic table was located. Boone said it sounded like the argument got louder as the group was near the picnic table at which point she heard a gunshot. Shortly after the first shot Boone heard someone running north past

her apartment and then heard several more shots. Boone did not see who was shooting, or who was being shot at.

Detective Mogg interviewed Robert Carter who said he was asleep in his apartment when he was awakened by his girlfriend Taneisha Deadmon. Carter said Deadmon told him she heard gunshots, so they both got out of bed, laid on the floor, and called 9-1-1. Carter looked out their bedroom window, which faced west, toward the parking lot and saw two people who were wearing dark colored hooded jackets jump the west perimeter wall. Carter went to the kitchen window and saw a black male on his hands and knees in the grass across from his apartment. Carter returned to the bedroom window and saw the two people who hoped the wall jump back over the wall and run north in the parking lot on the west side of the complex. Carter returned to the kitchen window and saw a black female wearing a blue shirt and jeans rolling the victim over. Carter and Deadmon live in apartment located in the northwest corner of building

Detective Mogg interviewed Dany Merino at the scene who said she was in her apartment between 2300 and 2400 hours when she heard five or six black males arguing in the grass area between her building, and building. Merino also heard what sounded like women screaming, but never saw who was screaming. Two black males, one of which was wearing a red jacket, were trying to calm down a black male armed with a scoped rifle, she thought looked like a military rifle. Merino described the male with the rifle as black, tall, thin, with shoulder length dreadlocks and dressed in black clothing. Merino did not see the face of the male with the rifle and cannot identify him.

Merino said the male was waving the rifle around, and she believed the argument continued for about 30 minutes. As the argument ended, the male with the rifle chased another black male who Merino believed lived in apartment in north in the grass area toward the parking lot, at which time she heard several gunshots. Merino believed the person who was being chased was hit because he stumbled while running. Merino saw the person with the rifle shooting. Merino described the person who was shot as a black male, approximately 5'6, medium build, wearing dark clothing. Merino believed the male with the rifle fired from the area near the animal waste receptacle east of her apartment. Merino cannot identify the shooter. Merino's apartment is located in the northeast corner of Building on the second floor, and she observed the incident from her bedroom window.

Detective Mogg interviewed Yasmine Martinez who said she was in her brother's bedroom in her upstairs apartment when she heard several people outside arguing. Martinez heard a male say, "you're not gonna hit me, you're not gonna shoot at me." Martinez said the group of people was arguing in the parking lot on the south side of her apartment building. Martinez reported hearing a female saying "why are you gonna shoot." She also heard other males saying "don't shoot, just put the gun down" prior to the shots being fired. Martinez said some of the people involved in the argument live in Building Apartment Martinez could not see the people involved, but said when the shots were fired the people ran south between Buildings and Martinez estimated there were approximately eight or nine shots fired and there was a couple of seconds between the various shots.

Martinez saw one of the people in the argument earlier in the day around 1530 hours and she described him as a black male, approximately 5'6, thin build, with shoulder length dreadlocks, and wearing a white t-shirt and blue jeans.

Detective C. Mogg interviewed Roosevelt Gipson who said he was in his apartment on 10/20/2013 at approximately 2330 hours when he heard 5 to 6 gunshots coming from the area south of his apartment near Building. Gipson thought the shooting sounded like two different calibers, but did not look outside to see who was shooting. Gipson said he was familiar with a person named "Sincere," and described him as a Black male, 20's, 6' tall, 190 pounds, with shoulder length dreadlocks. "Sincere" lived next door to Gipson in apartment. Gipson has never seen "Sincere" with a gun, and did not

know if "Sincere" had a vehicle. Gipson was aware of an argument involving "Sincere" and an unknown woman whom "Sincere" reportedly pushed. Gipson did not know the details of the incident and was not a witness to it.

Detective Mogg interviewed Eric Monterroso who said on 10/20/2013 at approximately 2000 hours he was in front of his apartment, with his family, cooking when a male subject walked up. The male approached him and commented on how good the food smelled. Monterroso asked the male if he wanted a taco and the two began talking. Monterroso described the male as Black, approximately 5'6, 150 pounds, shoulder length dreadlocks, wearing a blue short sleeved shirt and black pants. He also noted the male had black rubber bracelets on his left wrist. The male was drinking a "Mickey's" beer when he came over. They talked for a few minutes before the male left at approximately 2015 hours. A short time later, the male returned and their conversation continued for a few more minutes before the male received a phone call and left.

At approximately 2300 hours Monterroso was walking through the apartment complex and saw the same male with dreadlocks and several other black males by a picnic table near apartment arguing. Monterroso believed the victim, whom he saw later lying on the ground near apartment was one of the people involved in the argument with the Black male with dreadlocks. As Monterroso was walking near the picnic table he saw the male with dreadlocks grab a rifle from the enclosed patio of apartment Approximately 5 minutes later Monterroso heard several gunshots. Monterroso told Detective Mogg that on a previous occasion he asked the male with the dreadlocks where he lived and he replied upstairs on the north side of the complex. After the shooting, Monterroso saw the male with the dreadlocks and several other males jumped over the west complex wall in the northeast corner of the complex. Monterroso did not know the name of the male, but had seen him around in the apartment complex.

After the interview, Monterroso directed Detective Mogg to the front landing of his apartment where he pointed out a small white plastic trash bag that he said contained the green glass "Mickey's" bottle the black male with dreadlocks had been drinking from. The bag was photographed by Crime Scene Investigators and the green Mickey's bottle was collected. The bottle was processed and a print was recovered however the prints available for Green were insufficient for comparison.

On 10-22-2013 Detectives Wilson and Mogg obtained a recorded statement from Octavia Baker. At the beginning of the interview with Octavia, she signed a consent card giving detectives permission to search her apartment for various items related to the murders. Detective Wilson contacted Detectives Long and Embrey who conducted the search of Baker's apartment, while she was interviewed. Some names were located on paperwork inside the apartment and were documented however nothing was taken during the search. A small grayish colored pit bull puppy was located inside the apartment. Detectives ensured there was water and food for the dog however it was left at the apartment. The apartment was left closed but not locked, as it was found when Detectives arrived.

During the course of the interview Baker verbally identified "Sincere" as Christopher Green possibly from Texas. Detective Wilson texted Greens name to Investigative Assistant Flaherty, who searched Christopher Green through different computer systems. IA Flaherty texted Detective Wilson back a photo of Marquis Clemons, which was shown to Baker. Baker identified the subject in the photo as Marquis Clemons. She was later shown a photo of Christopher Green and identified him as her cousin who she knows as "Sincere".

Baker told detectives she had taken her young son to the store on Sahara across from the apartment complex. She bought him a Popsicle that he ate as they walked back through the middle of her complex toward her apartment. They came upon a group of people hanging out by the picnic tables at the east end of building Baker claimed she did not recognize any of the people there however detectives believe that to be untrue. She continued on to her apartment and as they walked up the

stairs to her front door Baker heard the beginning of multiple gunshots. She hurried inside and claimed she stayed inside her apartment the rest of the night.

On 10-24-2013, Detectives Mogg and Wilson interviewed Carlos Montes-Perez at his residence. Montes-Perez lives in the apartment outside of which the body of Teraye Lyles was discovered on 10-20-2013. Montes-Perez was home late in the evening of 10-20-2013 with his two children when he heard several African Americans arguing outside on the north side of Building Montes-Perez could not understand what was said, partially because he doesn't speak English very well. Montes-Perez looked out his dining room window and saw a black male carrying what appeared to be a small rifle. Montes-Perez described the male with the rifle as being approximately 6' tall, thin, 30 years old, shoulder length hair in braids, and wearing a light colored jacket. After seeing the male with the rifle, Montes-Perez heard one or two gunshots as the group moved east along the side walk on the north side of Building. Montes-Perez did not see who fired.

Montes-Perez moved to a window near his front door and saw a group of people and a woman carrying a small child. Detectives believe the woman and the child were likely Baker and her young son. After hearing the gunshots Montes-Perez ran to his children's bedroom to make sure they were safe. Approximately one minute later, while he was in the room with his children, he heard several more shots, which sounded further away. Montes-Perez said it was approximately 15 minutes between the time of the argument and when he heard the shooting. Montes-Perez did not recognize the person with the rifle and would not be able to identify him because it was dark.

Montes-Perez called his wife, Belitza Garcia, who was due to arrive from work and told her not to come home because there was a problem outside. Montes-Perez called his wife around 0545 hours and told her to come to the apartment because other cars were coming in the complex and the police were there. Montes-Perez watched out the window by the front door for his wife and when he saw her, opened the front door. When he opened the door he saw a black male (Teraye Lyles) lying in the space under the stairway. Montes-Perez hailed a Police Officer who was standing nearby and pointed the victim out.

On 10-24-2013, Detectives Mogg and Wilson showed a photo lineup to Mark Hale. Prior to the lineup, Detective Mogg read Hale the lineup witness instructions which Hale said he understood. Detective Mogg showed Hale the lineup containing a photo of Christopher Green and five similar looking black males. After looking at the lineup, Hale said photo six looked similar to the suspect's brother, but all of the other people in the lineup appeared heavier than the suspect whom he saw running with a rifle on 10-20-2013 at approximately 2340 hours. Hale did not pick Green out of the line-up.

On 11-07-2013, Detectives Wilson and Smith obtained a recorded statement from Gabriel Luna. During the statement Luna said he was watching television in the bedroom of apartment which is located at the upper southeast corner of building in the middle of the complex toward the north end. Luna went to the south facing dining room window and looked out. He saw several people running south along the east ends of buildings and possibly then heard another approximately 8 shots. He saw a black male with dreadlocks, approximately 5-10 with a thin build, wearing all dark clothing, and was carrying a rifle as he ran south as if chasing the others. This male was accompanied by two other subjects Luna could not describe. The subject with the rifle followed the other group out of sight and Luna heard what he thought were approximately 20 more shots. He is not sure if the subjects ran between building and and are recorded statement from Gabriel Luna.

Luna did not see the subject with the rifle's face so he can't identify him however he has seen a subject matching the subject's description before in the complex. The last time he saw him before the shooting was earlier the same day of the shooting and he has not seen him since. He said the subject is nice and he often saw him walking a small pit bull dog with a gray nose. It should also be noted that Octavia Baker had a small pit bull dog in her apartment when it was searched by detectives that matched that

description. Octavia Baker is the cousin of the Christopher Green and both of them had lived together in apartment until they had to move to another apartment due to water damage. Complex records indicated the apartment they moved into was apartment

On 11-20-2013, Detectives Wilson and Smith met with Anthony Johnson. Johnson was staying in the complex at the time of the shooting. He has known a Black male adult, late 20's to early 30's, 6-0, thin build, with dreadlocks who goes by the nickname of "Sin" or "Sincere" for the past few months. "Sincere" was living in the upstairs apartment above the apartment that was burglarized with his cousin "TayTay."

Detectives know that Octavia Baker uses the nickname of "TayTay" and lives in the apartment above the one that was burglarized. Johnson said that they have a blue pit bull puppy in that apartment that he has seen "Sincere" walking in the complex at times. Detectives also know that there was a gray pit bull puppy in the apartment when it was searched.

Johnson said that the day of the shooting he was sleeping and was later told by "Sincere" that he had tried to wake him up but Johnson was out cold. "Sincere" told him the apartment below, where he was staying, had been broken into and that the door was open. "Sincere" had tried to wake him to suggest there might be something good in the apartment he could take. According to Johnson he never entered the apartment. He was later confronted by a tall thin male and asked if he broke into the apartment. Johnson said he did not break in and walked away.

Later the same night Johnson was walking through the center of the complex and saw "Sincere" sitting with "Tay Tay's" boyfriend "Bird" aka "Joe Joe", who Det. Smith identified as Joseph Wallace ID#2713586. They were on the picnic tables next to one of the buildings by the fenced in picnic area. Johnson stopped to talk to "Sincere" and noticed the brown wooden stock of a rifle next to him. The rest of the rifle was hidden from Johnson's view. Being nosey, Johnson asked "Sincere" what was going on. "Sincere" told Johnson it did not concern him and that he should just head home. Approximately five minutes later Johnson heard "Sincere" yelling, in an apparent argument with an unknown person. Johnson recognized "Sincere's" voice. The arguing went on for approximately 5 to 10 minutes and then Johnson heard approximately 4 to 5 shots. There was a pause of approximately 30 seconds then he heard approximately 4 to 5 more shots. Johnson did not see who was shooting but is convinced it was "Sincere". He has not seen Sincere since the time of the shooting.

Johnson was shown a photo line-up with Christopher Green ID#2691276 in the top row middle position. This photo was marked with a number two. Johnson almost immediately pointed to the photo of Green and identified him as "Sincere". Johnson stated that he was 100% positive of his identification of "Sincere".

A partial print was located on the scope of the Marlin rifle located at the scene. The print was examined and could not be excluded as being from Christopher Green. Print detail was found in agreement with the left ring finger of Green, however the quantity of the detail in the latent print was insufficient to render a definitive conclusion. Prints belonging to Christopher Green were also located on a Steel Reserve beer can located under the bush near apartment of building. The prints connect Green to the scene and likely to the murder weapon.

Through the course of the investigation into the murders of Michael Dunbar and Teraye Lyles, the Marlin 9mm rifle, recovered at the scene, was identified as the murder weapon for both victims. "Sincere" was identified as the shooter of the Marlin 9mm rifle. Christopher Green was positively identified as "Sincere" and matches the description of the shooter provided by several witnesses. Prints recovered at the scene connect Green to the scene and likely to the murder weapon.
