



M. PRETTI, being first duly sworn, deposes and says:

That HE is a DETECTIVE with the Las Vegas Metropolitan Police Department, being so employed for a period of 9 years, assigned to investigate the crime(s) of SEXUAL ASSAULT AGAINST CHILD < 14; LEWDNESS WITH CHILD < 14 (2 COUNTS); LURE A CHILD OR MENTALLY ILL PERSON (2 COUNTS) committed on or about BETWEEN JULY AND AUGUST 2015, which investigation has developed YOUNG, NICK as the perpetrator thereof.

THAT DECLARANT DEVELOPED THE FOLLOWING FACTS IN THE COURSE OF THE INVESTIGATION OF SAID CRIME, TO WIT:

On October 29, 2015, Delain [REDACTED] (DOB [REDACTED]) along with her daughter, [REDACTED] (DOB [REDACTED]) walked in to the LVMPD Enterprise Area Command to file a report regarding Sexual Assault of a Child Under 14. Delain and [REDACTED] filed the report with LEST E. Eschker, P#9728, at Enterprise Area Command. The following is the narrative of that report:

[REDACTED] said she sometime in the middle of July 2015 she received a direct message on Instagram from Nick Young. The message said, "Hi (with a smiley face)." Young also sent a picture of his body from the torso up. [REDACTED] said she didn't know who Nick was, but started messaging back and forth with him. [REDACTED] said after about one day of direct messaging back and forth with Young, he attempted to get her to meet up with him. [REDACTED] said eventually Young blackmailed her into meeting with him by saying, "If you don't meet me I'm going to tell your mom you're trying to meet me, and you talked to me first."

[REDACTED] said she didn't want to meet Young, but she was afraid he was going to tell her mom, Delain [REDACTED] so she agreed to meet Young. [REDACTED] said she was scared to meet with Young, so she took her dog with her in hopes the dog would protect her. [REDACTED] made plans to meet Young on the street within her community. Young arrived in a dark gray 4-door vehicle (unknown make/model). [REDACTED] said during this first meeting, Young forced her to make out with him during and also touched [REDACTED] on her breasts and buttocks area (over her clothing). [REDACTED] said she told Young, "No," multiple times, but he ignored her demands to stop and continued to force [REDACTED]. She also tried to walk away from Young, but he held [REDACTED] by putting his arms around her, preventing her from leaving the area.

After the first meeting, [REDACTED] said Young again blackmailed her into meeting him by threatening to tell her mom, Delain. [REDACTED] said in fear of Young telling her mom, she agreed once again to meet Young for the second time. [REDACTED] said she again met Young in her community and he arrived in the same vehicle. During this meeting, [REDACTED] said Young forced her to put her hand on his penis and pushed her head down and forced her to perform oral sex on him. [REDACTED] said she tried to get away, but Young held her in his arms the entire time, preventing her from leaving. She also said she told Young, "No. Stop," multiple times which he ignored. [REDACTED] said during this second incident she was forced to touch him underneath his clothing. [REDACTED] said Young took his pants down on his own; she at no time unzipped the pants or tried to.

After this second meeting, [REDACTED] said Young again continued to try and blackmail her into meeting him saying, "I'll tell your mom everything." [REDACTED] said she told Young if he told her mom, she would go to the Cops. After this [REDACTED] said Young then left her alone and hasn't contacted her at all since.

[REDACTED] said Young has tried to do this with two of her friends as well. She said Young has attempted to do this same thing with 5-6 of her friends; at least 2 of them have been contacted since this last incident occurred. [REDACTED] said Young knows that these are her friends, because she is in pictures with them on their Instagram accounts.

Delain said [REDACTED] just told her on 10/28/15, because she told her friend via text message. Her friend's phone was taken away by their mom and she read the text messages [REDACTED] sent her friend. [REDACTED] said she felt she should tell her mom rather than hearing it from another parent."

LEST Eschker contacted your affiant, Sex Crimes Detective M. Pretti, P#9639, in regards to the details of the complaint. Your affiant advised an incident crime report be taken and would follow up at a later date.

On November 13, 2015, [REDACTED] [REDACTED] came into LVMPD Headquarters for an interview with your affiant; the following is a summary of her statement and is not considered verbatim, please refer to the transcribed statement included with this Declaration:

[REDACTED] was contacted via Instagram "Direct Message" by a 21 year old subject known to her as Nick at some time during the summer. [REDACTED] had never met Nick and was a not friend with him on Instagram prior to him sending her a message. [REDACTED] and Nick began communicating via Instagram until her aunt Nia found out and told her to talk talking to him. [REDACTED] continued talking to Nick on Instagram and he asked her to meet up with him. [REDACTED] stated that Nick told her that he would tell her mother unless she met up with him. [REDACTED] did not want her mother to know she was communicating with Nick, so she took her dog for a walk and met with him at approximately 2100 hours on the corner of her street, [REDACTED]. [REDACTED] stated that Nick pulled her face in and kissed her. [REDACTED] states that she got into the back seat of Nick's car, which she described as a dark grey car, with him. While in the back seat, Nick touched [REDACTED] breasts and buttocks with his hands. [REDACTED] stated that Nick pulled his pants down a little and put her hand on his "area". Based on [REDACTED] gesturing to her groin while describing his area, your affiant believes that she is referring to his penis. [REDACTED] attempted to pull her hand away, but Nick kept moving her hand

back to his penis and making her hand rub his penis. [REDACTED] stated that she was in the car for approximately an hour and was trying to reject everything Nick was doing so that he would think she was "wasting his whole time." Nick eventually left and [REDACTED] went home. [REDACTED] did not tell anyone what happened because she was afraid of her "parents being disappointed." [REDACTED] stated that Nick knew she was only 13 years old because she told him and he replied, "I know."

An unknown amount of time later, Nick again asked [REDACTED] to meet him in the same place, but without bringing her dog. [REDACTED] believes it was approximately 0100 hours. [REDACTED] met with him the second time because Nick told her he was going to tell her parents. [REDACTED] does not think Nick knows her parents, but knows her mother's Instagram. [REDACTED] stated that she again got into Nick's car where he kissed her and attempted to touch her breasts and buttocks. [REDACTED] also stated that "He put my head down to his, um, area and he made me do something I didn't want to." When pressed as to what Nick made her do, [REDACTED] stated, "Suck something." Based on [REDACTED] use of "area" in the same context as before, your affiant believes that [REDACTED] is referring to Nick's penis. [REDACTED] does not think this lasted very long, and she pulled away and tried to leave, but Nick was continuously pushing her head down. [REDACTED] stated she felt "sad and scared."

Nick attempted to meet with [REDACTED] one other time, but she told him that if he told her mother, she'd tell the police. After that time, [REDACTED] has had no contact with Nick and has deleted all of the messages from him. [REDACTED] told a friend, Gianna, about what happened. Gianna told her mother, which made [REDACTED] tell her mother. [REDACTED] stated that she would not have told her mother if Gianna's mother had not found out what was going on. [REDACTED] also believes that Nick has contacted some of her friends and is trying to do the same things with them.

Your affiant conducted records checks for the phone number [REDACTED], which was provided by the victim's mother. The records checks returned to Nick Austin Young, DOB [REDACTED] SSN# [REDACTED]. Your affiant left voicemails for Young on January 9, 2015, and again on January 14, 2015. Young called your affiant back on January 14, 2015. Your affiant explained to Young that he was the subject of a criminal investigation and afforded him the opportunity to participate in an interview. Young declined to come in for an interview, stating, "I don't really want to get involved in that."

Based on the above listed facts and circumstances, that [REDACTED] [REDACTED] alleges that Nick Young:

- 1) Lured her to his vehicle via electronic messaging where he rubbed her breasts and buttocks, and made [REDACTED] rub his penis;
- 2) Lured her to his vehicle via electronic messaging where he rubbed her breasts and buttocks as well as forced her to perform oral sex on him;

Your affiant believes that probable cause exists for Nick Young for Sexual Assault Against Child < 14, and 2 counts each of Lewdness with a Child < 14 and Lure a Child or Mentally Ill Person.

Wherefore, Declarant prays that a Warrant of Arrest be issued for suspect YOUNG, NICK on the charge(s) of SEXUAL ASSAULT AGAINST CHILD < 14; LEWDNESS WITH CHILD < 14 (2 COUNTS); LURE A CHILD OR MENTALLY ILL PERSON (2 COUNTS).
