Simpson started to run around the house yelling about his cell phone and the people following him. He stated he had thrown his cell phone in the garbage can in front of the house. Oliver told Simpson she was going to call the police if he did not calm down. Simpson calmed down and Oliver told Simpson to go find his cell phone. Simpson went outside and dumped the garbage can, located his cell phone, and returned inside the house. Oliver told Simpson to take a shower because he smelled bad after going through the trash. Simpson was still holding the handgun.

Oliver convinced Simpson to put the handgun inside his backpack. Simpson then gave Oliver the backpack and she put it on her bed in her upstairs bedroom. She stated she retrieved some clothes for Simpson to change into after Simpson showered. Simpson went into the downstairs bathroom, showered and went to the downstairs living room and was sitting on the couch. Oliver stated she came into the room and saw Simpson on the couch with his hand in the backpack. Oliver did not know that Simpson had retrieved the backpack from her bedroom.

Oliver stated Simpson pulled the handgun out of the backpack and again became agitated about someone following him and again stated they were outside the residence. Oliver stated she called 911 at approximately 1207 hours and stayed on the phone with the operator. Oliver told Simpson she had called the police and told him to calm down. Oliver attempted to move Simpson out of the house into the garage through the downstairs door. Oliver stated she opened the door and they went into the garage.

Once in the garage, Simpson walked around the vehicle parked inside the garage and was pointing his handgun inside it as if he was looking for someone. Simpson was yelling at Oliver there were people inside the car and Oliver was yelling at him to calm down.

Oliver stated that neighbors at Brandon Hughes and his mother, Felecia Wimberly-Hughes began to walk toward the open garage where Oliver and Simpson were arguing. Oliver stated Simpson saw them coming and went back into the house. Oliver followed and observed Simpson throw his handgun into the bathroom located just inside the garage door. Oliver went into the bathroom and attempted to get the handgun. Simpson followed her inside and they both struggled over the handgun. Oliver got the handgun and exited the bathroom and opened the door to the garage to exit the house into the garage.

Immediately outside the door, standing in the garage, was Brandon Hughes. Oliver stated Simpson shot Brandon Hughes and he fell on the floor just outside the door. Simpson continued out of the residence into the garage and Oliver followed. Oliver stated she began to scream at Simpson. Felecia Wimberly-Hughes quickly moved to Brandon Hughes' location. Oliver stated she grabbed a towel from the bathroom and gave it to Felecia Wimberly-Hughes and Felecia Wimberly-Hughes began to administer first aid to Brandon Hughes.

Oliver stated Simpson approached Felecia Wimberly-Hughes and grabbed her by the hair and struck her in the head with his handgun. Oliver stated she was standing at the door into the house and Simpson started yelling at Oliver that he would shoot her. Oliver moved inside the residence and Simpson fired approximately three rounds at her from inside the garage. None of the rounds Simpson fired struck Oliver. The rounds struck the back wall inside the residence and shattered the back glass sliding door.

Oliver stated she observed Simpson begin to drag Felecia Wimberly-Hughes by the hair to the front of the garage as she closed the door. Oliver stated she went to the downstairs bedroom located at the end of the hallway to check on her mother, Ruth Green, who was in a hospital bed in a bedroom. Felecia Wimberly-Hughes was later found deceased at the front of the garage by Officer Coovert. Felecia Wimberly-Hughes was motionless and the victim of an apparent gunshot wounds inflicted by Simpson.

Oliver stated she went upstairs to her bedroom. She stated she heard several gunshots while she was inside her bedroom. She went to her bedroom window and looked outside towards the front of the residence. She could see Simpson out in front still with his handgun. Oliver stated Simpson looked up to the window and saw her standing in the window, but she could not remember if he pointed the handgun at her.

Oliver observed an LVMPD motorcycle officer, (Officer Coovert) arrive on the street north of her residence. Officer Coovert walked toward her residence and Oliver stated she heard Officer Coovert give verbal commands to Simpson to drop his handgun. Oliver backed away from the window and heard several more gunshots. She looked out the window again and observed Simpson lying in the street. Oliver stated she then came back downstairs and exited the residence and was met by another LVMPD officer who took her into custody and moved her away from the residence.

Officers Lewis and Luna were dispatched, and arrived at the same time at Crazy Bull Avenue and Fast Elk Street. Officers Lewis and Luna stated they observed Simpson standing in the middle of the street north of their location armed with a handgun. Both officers gave verbal commands to Simpson to put the gun down on the ground. Officers Lewis and Luna stated Simpson put the handgun on the ground but stood next to the handgun.

Sergeant Kerns arrived at Crazy Bull Avenue and Fast Elk Street with his K-9 partner Nicky. Sergeant Kerns stated he observed Simpson in the street and deployed with K-9 Nicky and moved north toward Simpson.

Officers Luna stated Simpson quickly picked up the handgun and began to run northbound on Fast Elk Street. Sergeant Kerns released K-9 Nicky at Simpson. Sergeant Kerns stated Simpson turned as he ran away from the officers, pointed the handgun at them and began to shoot at the officers.

Sergeant Kerns, Officers Luna, Lewis, and Coovert returned fire at Simpson. Sergeant Kerns stated K-9 Nicky made contact with Simpson and Simpson went to the ground as the officers fired. Simpson collapsed in the street in front of and officers approached. K-9 Nicky had been shot and was lying on top of Simpson's right arm and his handgun was under K-9 Nicky. K-9 Nicky was deceased. Simpson was taken into custody. Medical personnel responded and transported Simpson to UMC Trauma.

Detective Jex responded to CCDC and booked Simpson in absentia for:

Murder with a Deadly Weapon Firearm, for when Simpson shot and killed Brandon Hughes,

Murder with a Deadly Weapon Firearm, for when Simpson shot and killed Felecia Wimberly-Hughes,

Attempt Murder with a Deadly Weapon Firearm, for when Simpson fired his handgun at Twila Oliver,

Kidnap, for when Simpson dragged Felecia Wimberly-Hughes by her hair to the front of the garage, and

Shooting into an Occupied Structure for when Simpson fired rounds into 9848 Fast Elk Street.
