COMPLAINANT STATES: I WORK AT THIS STORE, SO PLEASE KEEP THIS CONFIDENTIAL. THIS ISN'T REALLY ABOUT THE FOOD SPECIFICALLY, BUT I DIDN'T KNOW WHAT TO CLASSIFY IT AS. I HAVE WORKED HERE SINCE AUGUST AND WE HAVE ALWAYS HAD A PROBLEM WITH OUR DRAINS WORKING CORRECTLY. THE SINKS BACK UP, THE PIPES DRIP; WE HAVE TO HAVE CONTAINERS UNDER THEM AT ALL TIMES TO CATCH THE WATER. APPROXIMATELY ONE WEEK AGO, THEY GOT MUCH WORSE AND HAVE NOW BEEN CONSISTENTLY OVERFLOWING. EMPLOYEES HAVE HAD TO TAKE CUP-FULLS OF WATER, EMPTY THEM INTO OUR MOP BUCKET, AND THAT IS THEN BEING DUMPED OUTSIDE , FROM OUR BACK DOOR. IT'S DISGUSTING WATER, WITH FOOD PARTICLES IN IT.

INSPECTOR OBSERVATIONS: All food handlers and supervisor were aware of the situation. According to them, they have been contacting corporate to get their pipes fixed for awhile. Catch bins were observed under front handsink and under 3-compartment sink. Supervisor filled 1st basin with water 2/3 full, and attempted to drain; the floor sink backed up immediately. EHS left front handsink running for a few seconds before floor sink under 3-compartment sink started backing up even more.

No active leaks were observed under any of the sinks during the investigation. According to all food handlers, they take the bins filled with waste water and dump it outside into a storm drain.

Food handlers are unable to wash hands or warewash as floor drain backs up immediately after sinks turn on. The only working handsink is inside the employee restroom.

Other observations noted:

Active leak from ceiling at 3 different locations throughout the facility: in front dining area, on prep table in kitchen, and front prep area. Food handler observed food handling next to the active leak on prep table.

Facility is closed . Facility must make repairs so pipes drain properly. Additionally, the roof and ceiling must be repaired so no leaks occur anywhere in the facility.

You must cease and desist dumping anything outside. Solid Waste may follow up to verify compliance.

This complaint has been investigated with another complaint, CO0072883 (similar complaint). A routine inspection has also been conducted. See inspection report for more details.
