Overall Inspection Comments

ALLEGED COMPLAINT: FOOD TRAYS ARE NOT CLEAN (FOOD STILL ON TRAYS FROM PREVIOUS MEALS), ROTTEN AND SPOILED FRUIT IS SERVED, MAIN FOOD COURSE IS SERVED BELOW ROOM TEMPERATURE. JUICE CONTAINERS HAVE MILDEW AND SOMETIMES HAVE LINT AND HAIR PARTICLES. THE LITTLE FOOD THE INMATES RECEIVE COLD AND HAS LITTLE NUTRITIONAL VALUE. PLEASE INVESTIGATE-

Staff responded to the above complaint and observed and documented the following:

- No evidence of food waste noted on food service trays
- Pre-made sandwiches were being served past a 7-day shelf life.

*Food service staff were noted to be improperly cooling food that had been previously cooked for service. Hot holding units were currently out of use due to what kitchen staff stated were problems with the electrical system in the kitchen resulting in hot holding units tripping circuit breakers.

As a result kitchen staff stated they were using time as a control as a method of controlling pathogenic growth.

Foods held for use with time being used as a control were being cooled in a walk-in freezer and re-heated for later use.

NOTE: Above complaint was inadvertently assigned to the wrong PR#. Complaint should be assigned to PR0100632 which was inspected resulting in a "C" downgrade.

Complaint is valid. Permit holder being assessed \$118 valid complaint fee that must be paid by 1600HRS on 24 April 2018.
