

CRIMINAL COMPLAINT

The Defendant above named having committed the crime of DRIVING AND/OR BEING IN ACTUAL PHYSICAL CONTROL WHILE UNDER THE INFLUENCE OF INTOXICATING LIQUOR (Misdemeanor - NRS 484.379), in the manner following, to-wit:

That the said Defendant, on or about the 11th day of October, 2007, at and within the County of Clark, State of Nevada, did then and there wilfully and unlawfully drive and/or be in actual physical control of a motor vehicle, to-wit: a 2002 Ford, bearing Nevada License No. [REDACTED] on a highway, or on premises to which the public has access, to-wit: State Route 160 at Dean Martin, Las Vegas, Clark County, Nevada, while under the influence of intoxicating liquor to any degree, however slight, which rendered him incapable of safely driving and/or exercising actual physical control and/or while he had a concentration of alcohol of .08 or more in his blood or breath, and/or when the Defendant was found to have a concentration of alcohol of .08 or more in his blood sample which was taken within two (2) hours after driving and/or being in actual physical control of said vehicle.

THE UNDERSIGNED MAKES THE FOLLOWING DECLARATIONS SUBJECT TO THE PENALTY FOR PERJURY AND SAYS: That I am a peace officer with NHP (Department), Clark County, Nevada, being so employed for a period of 1(9) years (months). That I learned the following facts and circumstances which lead me to believe that the above named subject committed (or was committing) the offense of DUI - ALCOHOL at the location of SR 160 & DEAN MARTIN (ADDRESS / CITY / STATE / ZIP) and that the offense occurred at approximately 2322 hours on the 11TH day of OCTOBER, 2007, in the county of ☒ Clark or ☐ City of Las Vegas, NV.

DETAILS FOR PROBABLE CAUSE:

ON THE ABOVE DATE AND TIME I RESPONDED TO SR 160 AND DEAN MARTIN FOR A MOTORIST WHO WAS PASSED OUT AT THE WHEEL. UPON ARRIVAL I FOUND MEDICAL SPEAKERS WITH THE DRIVER OF A RED FORD PICK UP IDENTIFIED AS ERON BUSHELL. MEDICAL FOUND HIM ASLEEP AT THE WHEEL IN THE NORTH BOUND SR 160 TRAVEL LANES. I ASKED BUSHELL WHERE HE WAS DRIVING + HE SAID HOME. I NOTICED A STRONG ODOR OF AN UNKNOWN INTOXICATING BEVERAGE COMING FROM HIM AND HE HAD RED BLOODSHOT GLASSY EYES. I ASKED BUSHELL TO SUBMIT TO FIELD SOBRIETY TESTS AND HE REFUSED. BUSHELL WAS PLACED UNDER ARREST FOR DUI-ALCOHOL AND TRANSPORTED TO CLDC FOR EVIDENTIARY TESTING + BOOKING.

Wherefore, Declarant prays that a finding be made by a magistrate that probable cause exists to hold said person for preliminary hearing (if charges are a felony or gross misdemeanor) or for trial (if charges are a misdemeanor).
